# Senior Cycle Redevelopment Information and Updates

## Introduction

This is the seventh edition in a series of Department of Education Senior Cycle Redevelopment information notes. These notes provide updates to school communities on the roll-out of the Senior Cycle Redevelopment programme. The Department has issued this note to all post-primary schools and requests that it be circulated to students, parents and staff in each school. The information note will also be available online and schools are welcome to provide links from their websites and other digital presences to it.

# Launch of Road Safety Matters

This month, the Minister for Education launched the new Road Safety Matters transition year (TY) programme designed to help students become safer road users, developed in partnership with the Road Safety Authority and supported by An Garda Síochána. The programme has been developed to further support TY students and teachers, offering a step-by-step guide to prepare, educate and support students on their road safety journey. As part of the launch, the RSA has announced IPB Insurance as the official sponsor of the programme.

Pupils participating in the programme will learn the importance of sharing the road, developing the knowledge, skills, values and qualities to prepare them as road users and as safe drivers, if they decide to drive in the future. There are 10 modules in the programme including an overview session, learning to drive, components of a car, speed, alcohol, drugs, distractions, safety belts, vulnerable road users and an assessment.

The Road Safety Matters programme can be taught over a 10-week period or longer depending on a school's transition year timetable. Approximately 220 schools have expressed an interest in phase one of the programme, with over 110 schools registered for teacher training on the new module. 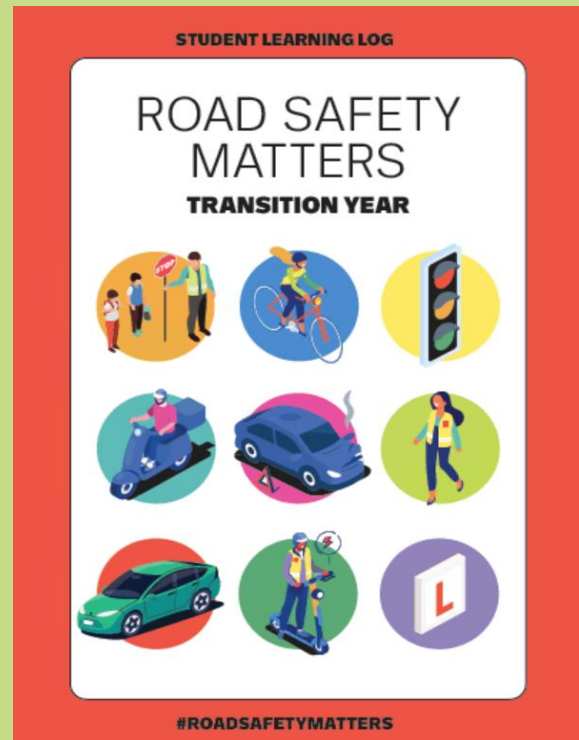
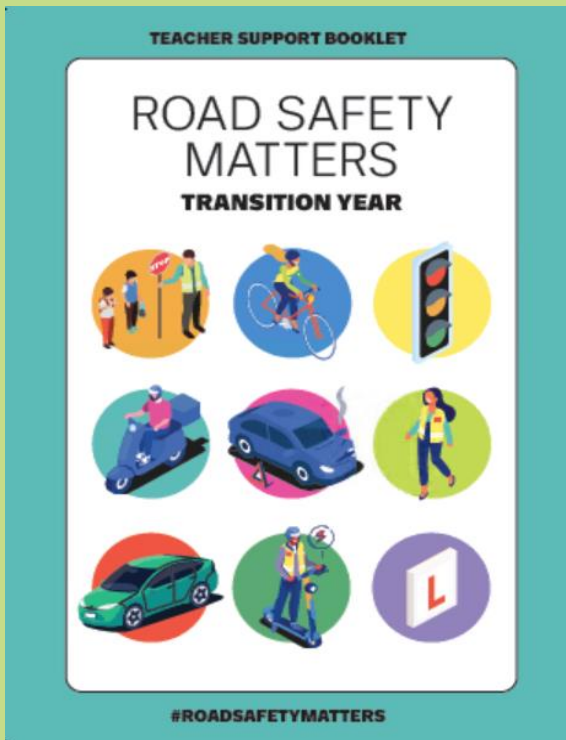

# Senior Cycle Redevelopment to date

In 2022, Minister Foley announced ambitious plans for a reimagined Senior Cycle of education for post-primary students, where the student is at the centre of their Senior Cycle experience.

Below is the high-level progress made to date on key Senior Cycle Redevelopment actions.

<b>Key Senior Cycle Redevelopment Actions</b>	<b>Progress to date</b>
Establish implementation and governance structures to ensure successful delivery of Senior Cycle Redevelopment	The Senior Cycle Redevelopment Programme Office, the Senior Cycle Redevelopment Implementation Group, the Senior Cycle Redevelopment Partners' Forum and Senior Cycle Redevelopment Programme Delivery Board have all been established.
Introduce Senior Cycle Level 1 and Level 2 Learning Programmes	Level 1 and Level 2 Learning Programme Statement and initial suite of L1 and L2 modules have been published.
Publish Transition Year Programme Statement, and work towards all students having the option of taking Transition Year.	The Transition Year Programme Statement has been published. Over the 2024/25 school year, all schools will have the opportunity to audit their current Transition Year offering and revise it where necessary in line with the Programme Statement.
All students in schools offering the Leaving Certificate Vocational Programme (LCVP) will be able to access LVCP link modules without meeting subject criteria from 2022/23.	LCVP Programme Statement has been updated to make Link Modules available to all students since Sept 2022. LVCP Link Modules being redeveloped in Tranche 2. LCVP uptake has risen very significantly – from 12,840 in 2023 to 17,234 in 2024. This is very welcome and is likely a positive response to the improved flexibility introduced under Senior Cycle
Students following the LCA programme will be able to access LC Maths and Modern Foreign Languages from 2022/23.	LCA Programme Statement has been updated to ensure access to LCE Maths and Modern Foreign Languages since September 2022.

# Senior Cycle Redevelopment to date continued

Key Senior Cycle Redevelopment Actions	Progress to date
SEC will certify the attainment of these learners reflecting both their LCA and LCE attainment, ideally in an integrated manner.	A small number of Leaving Certificate Applied students in 7 schools took subjects in the established Leaving Certificate in 2024. We expect to see this number grow in future years. These candidates received an Integrated Statement of Provisional Leaving Certificate Results through the Candidate Self Service Portal, which included both LCA and Leaving Certificate Established results, as well as an integrated certificate.
Deliver new and revised specifications, programmes and modules in annual blocks, incorporating Additional Assessment Components.	<p>All Tranche 1 subjects specifications have been published, and Tranche 2 and Tranche 3 subject development is in progress. The full schedule of subject specification revision can be found <a href="#">here</a>.</p> <p>Two new subjects - Drama, Film and Theatre Studies, and Climate Action and Sustainable Development - the Transition Year Programme Statement, the Level 1 and Level 2 Learning Programme Statement and initial modules, and the Senior Cycle SPHE specification have been published.</p>
Introduction of new subjects to broaden student choice	Specifications for new subjects Climate Action and Sustainable Development, and Drama, Film and Theatre Studies have been published. Phase One schools have been selected following an application process, with roll-out to take place in 2025.
NCCA to consider level of detail in curriculum documents to adequately support teachers.	Research completed and published. Template for technical form agreed for specification design of Tranche 1 to Tranche 5 subjects.
NCCA will assist in ensuring availability of appropriate and flexible progression routes into education, training, and work.	NCCA, in collaboration with SOLAS and ETBI, has developed an iVET TY module and are collating examples of FET taster courses being offered by FET providers. Work ongoing with SOLAS, ETBI and DFHERIS to progress further initiatives in this area.



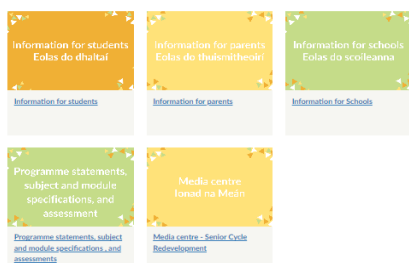
# New Senior Cycle Redevelopment website

# Supports for teachers and school leaders

To support school leaders in leading Senior Cycle Redevelopment in their school, Oide is embarking upon the provision of a comprehensive suite of supports for school leaders over the coming years, starting this year. Details of all events will be communicated in advance.

As an initial support, a presentation has been created for school leaders, with two key purposes in mind.

- Firstly, it serves to provide an overview of new developments in senior cycle, enabling school leaders to familiarise themselves with curriculum and procedural changes in the system, effective from September 2024.
- Secondly, and importantly, it offers a framework for school leaders to immerse teachers in discussions about these system changes. The slide format is designed to encourage teachers to participate with agency and autonomy as they engage with information regarding senior cycle redevelopment.

# Reminder: Sample Assessment Materials Timelines for Tranche 1

## Autumn 2024

Guidelines to support the AACs will be available to schools. These will be utilised by Oide in their SCR Professional Learning programmes.

## April 2025

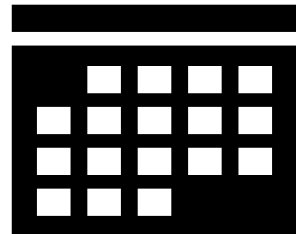
Four sample examination papers - two Higher Level and two Ordinary Level - for each subject in Tranche 1 will issue to schools. This is a total of 36 sample papers across the nine subjects– 72 papers in total when Irish Versions are included.

## September 2025

Specifications in new and revised subjects introduced in schools. A sample brief for the AAC in each subject will in schools at the same time.

## January 2026

A live brief for AACs for all subjects will be issued.
